## Introduction

#### Cyril Babeev Chair of Trustees

During 2023–2024, we supported 1,739 people, with 92% of members rating our services as "Very Good." We continued our collaboration with BRASP partners and secured new funding to sustain the vital work of this strategic alliance. In the same year, BRR experienced significant changes, including a CEO transition, governance restructuring, and notable developments in the national refugee and asylum seeker landscape.

I am delighted to share that in March 2024, Danielle Johnson became BRR's new CEO. Danielle is a distinguished leader in the refugee and asylum seeker sector, with decades of experience. She previously served as the Head of Integration and Refugee and Migrant Portfolio at Groundwork and most recently as the Refugee, Migrant, and Asylum Seeker Lead for the London Borough of Hackney.

We have also been fortunate to have new staff and trustees join us in 2023 and 2024. I welcome them all warmly!





#### Danielle Johnson CEO

I am so delighted to be joining an organisation which makes such an impact on people's lives and with such a committed team of staff and volunteers. Bristol Refugee Rights has delivered against the 5 goals of the 2022–2027 strategic plan in a meaningful and innovative way, including providing effective services, influencing system change, working in partnership, empowering people with lived experience and ensuring staff and organisational wellbeing and resilience.

Alongside the many impressive numbers you'll read in this report, what stands out is how these services have been designed in response to members' needs. Bristol Refugee Rights takes pride in including the experiences and voices of members at all levels of decision making, from service design to board level; with 42% of the board trustees having lived experience.

Behind every number is someone's life, a story of change, a positive experience of empowerment. Bristol Refugee Rights has created a community which has changed the lives of so many people, including those who are under-represented and marginalised – from housing support to immigration advice and creating a warm welcome for all new arrivals.

The staff and volunteer team are committed, working with members to reach outcomes against all odds. Against a background of increasing political and media hostility, people who came to the UK to see sanctuary

are navigating systemic injustice, including the Rwanda Plan, the Illegal Migration Act, and a large reduction in in legal aid, all of which increase the challenges to delivering effective services. Despite these barriers, this report outlines the many achievements and impressive impact staff and volunteers have achieved to uphold the rights of our members.

As a CEO, I'm proud to work here.




## **Our Members**

We call our service-users 'members' as a more empowering, equal term.


**Our Vision** A society where refugees, asylum seekers and migrants are welcomed, feel safe, live free of poverty and are able to positively build their lives. A society where everyone's rights and entitlements are respected.

**Nationality** Our Members came from over 65 different countries, speaking more than 35 languages. Their numbers map global human rights abuses: Taliban rule in Afghanistan, extreme repression in Iran, violent civil war in Sudan, increasing political persecution in Turkey. Between them, Afghanistan, Iran, Sudan and Iraq made up 46% of our Members.



#### **Immigration status**

The percentage of our members waiting for an initial decision on their asylum claim has increased year on year. This reflects a backlog in the asylum system which has built up due to the Home Office not making enough decisions. People are waiting years in hotel rooms and disused barracks, uncertain about their future, unable to start a new life and suffering from the effects of isolation, deskilling and poverty.



# **Member Survey**

Each year, we ask our members to complete a survey. It is an opportunity for them to tell us how they are doing, and to let us know how we're doing at meeting their needs. The answers help us adapt services.

The survey was conducted with members from October 2023 to April 2024 and showed:

#### **Overall**

# Services for people seeking asylum and refugees

**Strategic Goal 1:** Ensure services are impactful, accessible and designed to meet our members' needs.

#### **Welcome Centre**

Weekly drop-ins, open to all asylum seekers; a hub of social and community support where people can build connections, learn, volunteer, play games, make art and access support.

**1,113** visited our drop-in 2023-2024



- We served **more than 4,000** delicious hot meals
- We provided over 500 free haircuts
- We delivered more than 1,200
   helpdesk sessions, enabling access
   to services and support at BRR
   and around the city

#### Crèche

We run the only free crèche in the region for asylum seeking families.

**96** crèche sessions at BRR

**166** parents supported by our Early Years team

For Jannah, a space in our crèche for her son meant she could attend a group for people experiencing PTSD. She told us "It gave me a break without him. It was good to have that support as a single parent". Her son has Autism and she told us how in the long term, attending the crèche had helped him adjust: "It helped my child's settlement, it was very helpful for him to be able to stay without getting anxious. It helped [him] be confident around other kids and adults."

#### **Learning and Groups**

Learning is vital for well-being and for building a new life in a new country.

6 different levels of English classes and maths and wellbeing sessions

309 people joined our classes

After attending our classes:

"When I came to Bristol Refugee Rights, I couldn't speak anything – I could write, but couldn't respond when asked a question because I didn't have enough confidence – when I went to BRR they helped me to open my mouth and speak" Azeb even gave a classroom presentation about her views on technological change

#### Outreach in hotels

Working in hotels ensures support for those who need it.

192 visits to hotels

700 individuals supported, plus their families

#### **Asylum Guides**

Asylum Guides are volunteers with lived experience of the asylum system, sharing their knowledge to help others understand and prepare, building legal literacy, confidence and avoiding crises.

5 languages used to deliver Asylum Guides

145 members given information to navigate the asylum system

"I thought I knew lot of things about my situation but the session was an eye opener" Member


#### **Advice Service**

Our Advice Service supported **872** people seeking asylum, helping them navigate a complex system, to access services, and exercise their rights.

471 members received advice around how to access legal representation

434 members received advice around their rights to safe and appropriate accommodation and financial support

**143** members accessed additional advice aimed at preventing destitution



Before coming to BRR, Aariz was living in unsafe conditions with her children. She told us "I was really scared, distressed, nervous, frightened. I was thinking if anything happened to my kids, I would end my life." but after support from our advice team "I finally found safety, I felt at peace, any help I needed, there was a way of getting it."

#### **Specialist Services**

Delivering in depth casework and tailored support for groups with specific needs.

**Project CLEAR** supports some of the most at risk asylum seekers experiencing multiple, complex barriers to accessing support, including those with serious physical and mental health issues, drug and alcohol misuse, long periods of street homelessness and experiences of domestic abuse.

In depth casework with 17 individuals resulted in:

13 people now live in safe accommodation

10 engaged in mental health support

15 people now have an immigration solicitor who is progressing their case, the remaining 2 have been referred and are waiting

**5** Of these, 5 people have now been granted leave to remain

Our pioneering **Young People's Immigration Project** offers support to migrant children and young people:

**60 children**, either homeless or in unsafe accommodation were supported into safe accommodation

**50 young people** supported to challenge the age assigned them by the HomeOffice:



successfully established they are children



did not pursue due to stress and other barriers but maintain they are children



ongoing



Only 6% accepted that they were over 18

**Pride Without Borders** runs a social support session for LGBTQIA+ asylum seekers as well as doing wrap-around casework to support members.

27

PWB social space sessions, 85 members engaging with the project 34

members have had successful asylum claims, PWB providing supporting evidence **32**

# **Experts by Experience**

**Strategic Goal 2:** Empower and work in solidarity with people with Lived Experience

We work with Experts by Experience\* at all levels of the organisation, including members, volunteers, staff and trustees. In 2023/2024:

out of our 33 staff were experts by experience

out of 9 trustees were experts by experience

#### **Expert by Experience** Ezzeldin Ali

"I arrived in the UK alone in October 2022. With no money or anyone to turn to, I felt trapped in a situation that mirrored a Sudanese open prison. I couldn't work (no right to work), or study for the first six months.

"Then, I found a beacon of hope in BRR. They offered me a chance to volunteer as an asylum guide. They trained me, provided resources, and empowered me. This experience transformed my life. My English improved dramatically, I connected with my community, and finally felt free.

"After I received refugee status, BRR again supported me, this time by supporting me to apply for a paid job at BRR to utilise my skills."

"Today, I'm a confident person with a network of friends and colleagues. I can support myself and my family. I'm eternally grateful to BRR for the life-changing opportunity they gave me."

#### **Member Voice**

BRR's Members Voice Group empowers members to input into key decisions and guide strategy and services. It encourages a rich diversity of points of view. We explored whether Members felt BRR embodied the values of Solidarity and Empowerment. They were overwhelmingly positive, reminding us that we are embodying these values for a reason.

"Solidarity is about holding hands. It's about being stronger together, and knowing that some people's voices are heard better than other people's voices, so it's better to stand together" Aimee

# **Organisational Wellbeing**

**Strategic Goal 3:** Be sustainable and invest in the wellbeing and resilience of our people and organisation

#### Staff at BRR

We filled 12 vacancies during the year, supported internal progression and recruited volunteers into paid roles. We offered 27% of jobs to people from a refugee background, increasing our proportion of Experts by Experience.

#### **Volunteers**

We had an amazing team of 108 volunteers over the year, including 34 member volunteers. The sense of community is facilitated by how BRR gets advice from members on how to run, creating inclusion. "The staff and other volunteers treat me as one of them, with no-discrimination."

#### There's real commitment:

- 23%, have volunteered for us for between 5 and 10 years
- 40% between 1 and 5 years
- We have also recruited 50 new volunteers over the past year

#### **Member Volunteers**

We worked closely with our team of member volunteers to create a rich volunteering experience. Volunteering with BRR gives members the opportunity to share their skills and expertise with us, increase their knowledge and pick up new skills.

# **Partnerships**

**Strategic goal 4:** Use partnerships to increase impact and resilience

"There is no other group doing what BRR do in the South West. They plug the lacuna. Their services are absolutely vital and specialist" Bristol Sector Partner

We believe in strong partnerships. Bristol Refugee Rights is a founding partner of Bristol Refugee and Asylum Seeker Partnership (BRASP). In 2023/2024 BRR continued hosting BRASP and secured further funding for a coordinator, enabling work such as:

- Forums and networks for information sharing
- Responding to the significant increase in the number of hotels in central Bristol
- Shared training and resources
- Developing service mapping ahead of a signposting and referral tool for the sector

The **BRASP partnership** has led to two key jointly funded projects: Bristol City Council Impact Fund – and Supporting Asylum Seekers and Refugees Together, funded by the National Lottery.

We are proud members of **Bristol Migrant Forum**, which shares
best practice, including for anyone
whose work impacts refugees and
migrants.

We continued our strong partnership with **Bristol Law Centre**, expanding our co-working model to include new areas of law.

Through the **Refugee Action** led 'Explore, Adapt, Renew' programme, we continued our work with 6 partner organisations across the UK to develop and share best practice with.

Our Young People's Immigration Project continues to coordinate the **Young People's Forum**, a network of 38 local organisations working to ensure young people can access the immigration advice they need.

# **Action for Change**

Strategic Goal 5: Raise our profile to influence others

#### **Strategic Litigation**

This year we supported **3** significant legal challenges against issues in the asylum system, providing evidence to support

- **DPG** challenging the decision not to give extra financial support to pregnant women and new mothers living in Initial Accommodation. This resulted in a back dated payment increase.
- **Public Law Project** challenge against the mismanagement of the Legal Aid contract. This ongoing crisis in Legal Aid immigration advice continues to be one of the biggest challenges affecting our members
- **LawStop** bringing a challenge against long delays in decisions on asylum support applications

#### **System Change**

We have worked with Bristol Law Centre and regional partners to create a new referral pathway and make steps to increase the availability of free immigration advice across the south west

Our Young People's Immigration project coordinates the Young People's Forum to promote best practice among **38** organisations supporting young migrants.

We have continued to develop work with Local Authorities to encourage best practice for young migrants in care:

- 9 drop in advice sessions at Bristol City Council (BCC) for social workers and PAs – on average 4 appointments per advice session
- Monthly meeting with Social Workers to discuss referrals for age disputed children
- Supported the Local Authority to engage with national networks ie. Immigration Special Interest Group for local authorities and partner organisations, and supporting BCC to meet with members of the Refugee and Migrant Children's Consortium on their immigration pledge for children in care

## **Finance**

BRR's total income in 2023/24 was £897,988. This includes multi-year restricted funds for use in subsequent financial years. BRR's total expenditure in 2023/24 was £940,158. Most of our funding came from trusts, foundations, Bristol City Council and National Lottery. £101,694 of income came from individual donations and subscriptions.

All funding received has been vital in ensuring that we can continue to be here for our members. A full copy of our Trustees report and further detail on 2023/24 finances can be found in our Annual Financial Statements 2023/24 which are submitted to the Charity Commission and are freely available on our website.
